The International Plastic Waste consultant will report to the PIU Project Director and work alongside the plastic waste expert. - Excellent drafting and writing skills including for a variety of reports and audiences
- Experience in providing similar services in the last five years.
- Experience in the South Asia Region in the last five years.
- Experience in coordination with national governments and/or enforcement authorities, managing stakeholder relations with other key players, including academic, civil society, business, and international organizations, is required.
- Prior experience in managing and developing projects of projects financed by development agencies will be preferable.
